

Consumer Bulletin from the Pennsylvania Office of Consumer Advocate Announcing Additional Public Input Hearings Regarding the Proposed Rate Increase Request of Pittsburgh Water and Sewer Authority Docket No. R-2023-3039920 (Water) Docket No. R-2023-3039911 (Wastewater) Docket No. R-2023-3039919 (Stormwater)

The Pennsylvania Public Utility Commission (PUC) has scheduled two **additional** telephonic hearings on August 29th, 2023, to gather information from ratepayers regarding Pittsburgh Water and Sewer Authority's proposed rate increase. These public input hearings are in addition to the public input hearings that were already held in July in this case.

The Office of Consumer Advocate (OCA) has filed complaints in these proceedings and is actively challenging Pittsburgh Water and Sewer Authority's request for a rate increase. The OCA represents consumer interests and encourages all customers affected by the proposed rate increase to participate in the public input hearings.

The Public Input Hearings will be held telephonically on Tuesday August 29, 2023 at 1 P.M. and 6 P.M.
